CARRIER BOY'S LEASE

THIS AGREEMENT Made by and between the Palladium Publishing Corporation, publisher

of the Palladium and Item, hereinafter designated as PUBLISHER, and Rudolph Fienning of Richmond, Indiana, hereinafter designated as CARRIER BOY,

WITNESSETH:

Said Publisher hereby leases to said CARRIER BOY a certain list of subscribers who purchase the PALLADIUM-ITEM and who live on a certain paper route in Richmond, Indiana, described, as follows:

South Sthatreet from South E. to South L. Also side streets to alleys east and West of South 8 th street.

Said CARRIER BOY, on his part, agrees, as follows:

- (1) That he will regularly and promptly sell and deliver said newspaper to all of said subscribers at the established rate therefor;
- (2) That during the term of this lease he will not sell or deliver any other newspaper without the written consent of said Publisher;
 - (3) That he will do all in his power to promote and extend the circulation of said newspaper;
- (4) That prior to giving up said newspaper route he will give said Publisher two weeks notice of his intention so to do;
- (5) That he will not turn over said list of subscribers to any person, nor disclose the name of any subscriber of said newspaper, without first obtaining the consent of said Publisher;
- (6) That he has not paid any money to any person for this list of subscribers, and that he will not sell it to any person for any money;
- (7) That he will regularly and promptly pay each continuous for all copies delivered to him in accordance with this agreement at the established wholesale rate; for all copies of said newspaper
- (8) If he collects in advance from any of his subscribers, then on the termination of this agreement he shall report all such collections and account for the same to the new carrier boy on such route;
- (9) In the event he is unable to carry said route on any occasion, then he will provide a substitute to act for him.

Said Publisher agrees, as follows:

- (1) To furnish all issues of said newspaper published by it to said CARRIER BOY exclusively on said route, and at the wholesale price established by it from time to time;
- (2) That it will at all times maintain a sale price on said paper, both to the CARRIER BOY and to the subscribers, that will permit a reasonable profit to be made by said CARRIER BOY on the papers which he sells on said route.

It is mutually agreed, as follows:

Said CARRIER BOY has deposited with said Publisher the sum of \$.00, and he shall add One

Dollar \$(1.00) a week to such sum until the same becomes \$161.00....... Such deposit shall be retained by said PUBLISHER as a guarantee of the performance by said CARRIER BOY of his obligations under said lease. When said lease is terminated, either by the Publisher or said CARRIER BOY, then the money on deposit shall be paid to said CARRIER BOY. If said CARRIER BOY, at the termination of said lease has

paid in the full amount of said deposit, \$61.00, then he shall be paid the sum of One Dollar (\$1.00)

for each regular subscriber on said route in addition to 161....., the same being the present number of subscribers. In the event that said number of subscribers at the time of the termination of said lease is less than the present number, then One Dollar (1.00) for each subscriber lost shall be deducted.

Said Publisher shall have the right at any time to terminate said agreement, and in such event said Carrier Boy shall surrender to said Publisher his complete list of subscribers.

As said Carrier Boy is a minor, his undersigned parent, or guardian, hereby agrees to be responsible for the performance of all of the obligations of said Carrier Boy.
